## STEPHANIE E.W. THOMPSON

Stephanie E. W. Thompson is a Director of the firm. Ms. Thompson concentrates her practice in the areas of commercial and real estate civil litigation and e-discovery information management law. ## Executive Insight

# STEPHANIE E.W. THOMPSON

Director and partner,  
Starn O'Toole Marcus & Fisher

As a kid, Stephanie E.W. Thompson would borrow her father's briefcase and pretend to be a lawyer. He eventually built her a desk where she kept files and a toy phone, she recalled in an interview with Pacific Business News.

"I don't know where that came from," Thompson said. "We laughed about it a lot because nobody in my immediate family were lawyers."

Today, she's living her childhood dream as a director and partner at Starn O'Toole Marcus & Fisher, where she focuses on commercial and real estate civil litigation. The firm has 25 attorneys, she said.

Thompson graduated from University of Hawaii at Manoa William S. Richardson School of Law as a single mother of three teenagers when she was 42 years old. Previously, Thompson had been a middle school French teacher, but she decided to become a lawyer after family changes left her wanting a career with a higher salary to support her children.

"The question was put to me: 'What is it that you've always wanted to do?' Believe it or not, I always wanted to be a lawyer," she said.

When Thompson is not working, she is also a triathlete, mara-

thon runner and surfer.

She spoke with PBN about her hobbies as well as industry trends, challenges and advice for lawyers starting out in the profession.

**Is there any overlap in the skills you build through your hobbies and those you use at work?**

[My sense of competition in my hobbies has decreased quite a bit], so more and more I'm out there for the community and the pure enjoyment of it and meeting my own personal goals. And then transfer that to the office – in so many cases, we're zealous advocates for the people that we represent, and there are a lot of things that are out of our control, and yet we've got to find a way [to] push forward ... and still, on a personal level, have it be rewarding and fun. In many instances, it's very much like [a] triathlon. And I was really attracted to my particular law firm because at the time that I joined my law firm, there were two very good triathletes there.

**What trends are you noticing in litigation right now?** Well, one of my focuses is on the practice of e-discovery and information governance, and that's an area of litigation that deals with digital

records and documents. The technology has just exploded in the last 10 years, and a big part of litigation has to do with collecting and reviewing the documents that made a deal, and most of it's in digital format. ... Now, one of the hot ticket items that people are collecting from are the links embedded inside emails. ... You have a collaborative document, right? And you have a link, and everybody contributes, or they make edits, or they make comments about this and this and this. You have now this document – which is a contract that's in dispute – and you want to see who said what about what provision or who deleted what. You've got to go back and you want all those documents in their original format when you sent it back in 2022. These types of software – and ways

to go do that – preserve those types of links and allow you to go back and review all those changes. It's really a super interesting part of litigation.

**What is your biggest challenge right now?** I think the biggest challenge is staying abreast of the case law and technology, while at the same time keeping a balance in personal and family life. It's always a challenge. ... But I think that's not just in the legal field. I think that could be said of most everybody and what they do and how they do it. I think in the legal field, we're feeling the impacts of artificial intelligence [and we're trying to use it] to do our job smarter and better – so that the client gets better service for less money. And [it's] good for the client, because in many aspects, legal representation is so expensive. One of the things near and dear to my heart is this concept – which Hawaii is out in the forefront of – of access to justice, where people who need representation but can't afford it, can get it. And I think that this whole push for AI and technology and things like that will make it a little bit easier for almost everybody to have the legal representation that they need.

**What advice would you give someone going into the legal profession?** I would say "do it" because there are so many skills that you glean in just having to think and analyze like a lawyer. I forget the statistic, but very few people stay as active attorneys. They branch out into so many different areas of business. To be able to communicate succinctly and precisely – verbally and in writing – will serve anyone anywhere, anytime.
